Witnesseth that the said Alexander McDonald and Margaret McDonald for and in consideration of the sum of eighty pounds of lawful money of Nova Scotia to him in hand by the said John McDonald well and truly paid at or before the sealing and delivery of the presents the receipt whereof is hereby acknowledged. Hath granted bargained sold enfeoff, released and confirmed and by these presents doth grant, bargain sell enfeoff release and confirm unto the said John McDonald his Heirs and Assigns All that piece parcel or lot of land situate lying and being in the Soldier's Grant (so called) in the County aforesaid and bounded as follows that is to say Beginning at a Cherry tree standing on the North Western bank of the North River thence running north forty seven degrees west until it comes to the rear line, thence north forty three degrees East thirty two rods or until it comes to the angle of Bernard O'Neill's land or lands lately in possession of David Graham thence South forty seven degrees East untill it comes to the angle of lands owned by Alexander Thomson thence south forty three degrees West thirty two rods or untill it comes to the place of Beginning being bounded towards the South West by lands in the possession of John McDonell Blacksmith, toward the North West by lands laid off for School, towards the North East by lands lately owned by Bernard O'Neill and now in possession of David Graham and towards the South East by lands owned by Alexander Thomson and containing Ninety Acres more or less together with all and singular outhouses, barns, buildings, ways, woods, waters, watercourses, easements, commodities, hereditaments and appurtenances To the said lot of land belonging or in any wise appertaining and the reversions and seversions remainder and remainders unto issues and profits thereof, and all the estate right title interest claim property and demand of him the said Alexander McDonald and Margaret McDonald in to upon or out of the said lot of land and premises with the appurtenances to Have and to Hold the said lot of land and premises with the appurtenances and every part and parcel thereof unto the said John McDonald his Heirs and Assigns to his and their own and only proper use benefit and behoof forever.
